Introduction:

This staff report recommends that the City Council adopt a resolution expanding the designated area of Tomodachi Park.

Tomodachi Park:

Tomodachi Park was completed in 2013. The 8.7-acre open space park is part of the Laguna Wetlands Preserve and includes short trails, a picnic area, oak woodlands, and riparian forest.

Tomodachi Park is on the same parcel, and adjoins the Park Village mobile home park. The overall property is owned by the City.

The City Council expressed interest in designating a portion of the Park Village area as part of Tomodachi Park, specifically the large grassy area behind the split rail concrete fence, on the west side of the Tomodachi/Park Village Highway 12 frontage, that includes the community garden area.

A resolution is attached to accomplish that designation. Designation of the area will expand the official park area, and may assist the City in future park improvement grant applications.

Whereas, Tomodachi Park, an 8.7-acre component area of the Laguna de Santa Rosa Wetlands Preserve, was completed in 2013; and

Whereas, the park includes short trails, a picnic area, oak woodlands, and riparian forest, and has access to the Laguna channel; and

Whereas, Tomodachi Park is on the same parcel and adjoins the Park Village mobile home park, and the overall property is owned by the City of Sebastopol; and

Whereas, to expand protected park area, the City Council has expressed interest in designating a portion of the Park Village area as part of Tomodachi Park, specifically the large grassy area behind the split rail concrete fence, on the west side of the Tomodachi/Park Village Highway 12 frontage, that includes the community garden area and is approximately 0.8 acres in size.

Now, Therefore, Be It Resolved that the City Council of the City of Sebastopol hereby finds, determines, declares, and orders as follows: that area shown as the "Tomodachi Park Expansion Area" on the exhibit attached to this resolution is hereby designated as part of the City's Tomodachi Park.
