- Pictures for messaging

Portia – reinforce – hear something ten times before integrated into brain

- Keep in public purview
- Reinforced at all times
- Keep ball in the air
- Talk about it a great deal

Councilmember Carnacchi commented as follows:

- Ban prohibited retail sales- discussed Safeway and Lucky
- How does small municipality like Sebastopol fight big corporations if they are going to sell it anyways
- Screamin Mimi eating at other establishment attractive to use steel spoons to eat with makes business more attractive
- How measure the diversion rate
- Is there proof to diversion
- 10 cent tax on single cup use and lids

### Patrick – happening in other cities

- City has authority to do this
- Has been done elsewhere
- SCWMA can get involved
- Discussed measuring of diversion
- Back in the day was percentage rate
- Method changed in recent years how much landfilling
- Discuss statistics with garbage company
- Discussed the 10-cent fee If City wants to add on to the ordinance is at City discretion
- County proposing five measures

Councilmember Carnacchi commented as follows:

- Asked for commitment tonight
- 100 percent post

Mayor Slayter – that can be added as topics to be discussed.

Councilmember Glass commented that there is no other city in the County that is already committed to zero waste.

Sunny - Have to act fast City of Sonoma in the act of doing event permitting

Mayor Slayter questioned if there are other cities in the State.

Leslie stated there are many cities in the State already that are Zero Waste

Mayor Slayter discussed taking actions to ensure success.

- Discussed the summary (growlers and kegs)
- There is no outlet in City that refills them as matter of policy

Portia – individual business policy Can be done – can be refilled – has to have right name on it

A member of the audience commented that a brewery can refill anyone's growler, has to put on approved ABC label.

Mayor Slayter commented as follows:

- Discussed HopMonk
- Suggested mention to them that this could be a way to assist community in moving towards zero waste
- Discussed the construction industry making changes

Portia – stated most cities that have Zero Waste have standards for the building community

- Have to work with the Builders Exchange in Sonoma County
- Needs to be resuscitated

Mayor Slayter stated it is mandated to have a waste management plan.

Leslie- CalGreen has a 65% diversion requirement

- Discussed the City of Santa Rosa zero waste plan
- Discussed construction/demolition ordinance

Sunny discussed questions on the comment cards.

- Three questions pertaining to Recology
- Where is Recology composting plant how far does it travel

Collected in Sonoma County – goes to Novato, Ukiah, or Richmond

What is the current status of recycling plastic film and plastic bags

- Material gets caught in machinery at facility problematic can also contaminate the paper bales
- Not able to accept it in recycling program
- Grocery stores can accept the plastic bags

When we will be getting compost kitchen pails from Recology

- Would love to get them to everyone
- Expensive to do that
- City of Santa Rosa got the pails and new carts and new trucks
- Something to negotiate with City
- Can reach out to Recology will provide

Will electricity at the compost facility come from solar

Exploring that option

Met with Board of Supervisors – Looking to implement Zero Waste policy at the County level

- Discussed the permitting process
- Discussed usable wears
- Discussed health codes nudging permitting process
- Discussed Peace Town use of cups
- Discussed use of reusable containers at hot bars in the County
- Can bring it for left overs

How do we manage to handle vendors who refuse

- Keep going until someone will do it
- Health code will catch up
- Making great headway towards permitting of reusable wares

Why hasn't the city of Sebastopol banned poly-styrophoam of the City

Mayor Slayter discussed the next steps.

#### **PUBLIC COMMENT:**

- O Speakers are allowed to speak for a maximum of three minutes so that all speakers have an opportunity to address the City Council. Power point or visual presentations for public comment shall not be permitted unless approved by the Agenda Review Committee two weeks prior to the requested meeting date.
- o Yielding Time: Speakers may not "yield" a portion of their allotted time to others.
- o The Mayor has the authority to limit or extend the time allowed for speakers dependent on the number of speakers in attendance.
- The Mayor can poll the members of the public for an indication of the number of people wishing to speak, then call on individuals to speak.
- o It is the goal of the Council to conclude the public comments portion of the agenda within 20 minutes. If the public comment period exceeds twenty minutes, the presiding officer, typically the Mayor, reserves the right to reduce the time per speaker or carry over public comments to after all business items are completed.
- The City Clerk will monitor the time for public comments and inform the speakers when the time limitation has been reached.
- o The Mayor could survey the members of the public, as appropriate, to move agenda items up or back to address the members of the public items of concern.
- o Public participation is encouraged on all public agenda items.
- o Council and staff will treat participants and each other with courtesy. Derogatory or sarcastic comments are inappropriate.
- o The public will likewise be encouraged by the Mayor to maintain meeting decorum.

#### Engineering Manager Mikus commented as follows:

- Discussed explaining the green painted lines safety enhancement for bicycle lanes solid green and striped green lines
- Solid = bike lanes
- Striped = transitions in lane structure or where traffic and bikes will cross
- Discussed comments received such as dooring discussed similar situation on Morris Street did not change lay out but did enhance safety as added striping provides warning to drivers

7. Discussion and Consideration of Potential Actions for Morris Street Camping Issues to Include Recommendation for Revision of Existing Ordinances (Police Chief)

Police Chief Conner presented the report to the City Council, provided history of the item, and recommended that the City Council discuss the recommendations as outlined by staff:

- 1. Consideration to Establish a "Parking Prohibited Midnight to 6:00 am." zone on both sides of Morris Street, between Sebastopol Avenue and Johnson Street; both sides of Johnson Street, between Morris Street and Sunset Avenue; and both sides of Laguna Park Way, between Morris Street and McKinley Street.
- 2. Enact a Municipal Code section prohibiting parking or storage of oversized vehicles on the public right-of-way in residential areas.
- 3. Rescind SMC section 10.40.090 TRAILERS, as it is unenforceable in current form.

Mayor Slayter opened for questions.

Councilmember Carnacchi commented as follows:

- Name of Street of Brookhaven (Valentine) construction workers who have unlimited race cars park on street
- Are those illegal

Chief Conner commented as follows:

- Stated it would depend and discussed the definition of oversized vehicles and stated that those cars on a flatbed trailer would probably in violation
- City street is not a parking lot

Mayor Slayer commented as follows:

- Restrictions for other municipalities
- Un-hitched trailers definition

Councilmember Gurney commented as follows:

- Motor boat on trailer unhitched
- Fifth Wheel trailer without truck
- Utility trailer
- Box trailer
- Winnebago/RV

Chief Conner commented it would most likely fall under oversized vehicle definition depending on the municipality's definition. He also discussed complaints oversized vehicles for site distance, crowding, neighborhood aesthetic, etc.

Mayor Slayter discussed sizes/definitions from other jurisdictions.

#### Councilmember Carnacchi commented as follows:

- Discussed a permit process
- Allow to happen by permit to allow oversized vehicles
- Discussed the City Manager's street
- Residents notified of permit

#### Chief Conner commented as follows:

- Permit would be issued by police department
- No public hearing
- Similar to alcohol in park permit
- Not recommending that
- No ability to track that
- Discussed passes for parking
- Discussed obligation to enforce with permits
- Problem for the city to do no staff

#### City Manager McLaughlin commented as follows:

- Discussed neighborhoods
- Most neighborhoods not designed for oversized vehicles for each house would not fit
- Not know fairness of first come first serve for permit

Mayor Slayter opened for public comment.

#### Gregory Fearon commented as follows:

- Lives in Santa Rosa
- Alerted to issue
- Deeply involved with issue of people living on the streets
- Location in Santa Rosa has 31 RVs
- Define what city is and how it works
- People are change figure out how to accommodate that
- Discussed people living on the streets
- A lot of people living in RVs full time
- Trying to find a place for them
- Failure of society to build housing
- Suggest Sebastopol entitled to \$12.1 million from County in next couple of months
- Discussed spending the money on homeless
- Encourage the City to go to newly formed CofC on October 18<sup>th</sup>
- Ask for money
- 9 people decide how those funds will be spent to address housing of homeless

#### Yvette Morris commented as follows:

- Owns camper
- Lives in Sebastopol
- Been homeless
- Speak on their behalf
- Pitiful for people to want to make a law to where it is illegal for someone who is homeless to survive other than in the bushes
- Own a motorhome on Morris Street
- Not allowed to park
- Legally registered ensured vehicle
- Where do you expect the homeless people to go
- When homeless Have no money Destitute need place to live
- Thanked WCCS
- A lot of people are homeless and are scared to come here
- Need to help not hurt the homeless
- Grateful someone helped her
- Trying to help the homeless
- Not going to go away
- Not going to get rid of them by doing this
- Creating more problems
- Need somewhere to live

#### Steve Dillan commented as follows:

- Lives on Taft Street
- Watching RVs coming into neighborhoods
- If make Morris Street illegal going to start distributing in the neighborhoods
- Request that concept be addressed prior to putting concrete poles in the ground
- Difficult problem
- Compassion
- Like to know who is living in his neighborhood

#### Colleen Fernald commented as follows:

- Quasi homeless
- Discussed just cause eviction
- Discussed seasonal camping at Park Village
- Discussed additional ways to help people survive losing their home
- Forced out of her home
- Tried to rescue herself from losing everything
- Negotiated for the RV she is in now
- Accommodate seasonal camping at Park Village
- Hard to move forward from being homeless
- Discussed social and environmental help needed
- Discussed County having park land for RVs
- Discussed tiny homes or RVs
- Safe place to be
- Does not have that

- City not listening
- Problem escalating

#### A member of the audience commented as follows:

- Own business on Morris Street
- Intimate with homeless on Morris Street
- In middle of situation
- Heartbreaking
- Employed homeless
- In center of epicenter
- Now elevated
- No answers
- Community how help them what can we do
- See drug deals
- See people using the area as a restroom
- Saw a machete
- Police been fantastic
- Not asked anyone to leave not been disrespectful been phenomenal
- Have been trying to find solution
- Discussed porta potties
- Bike path dangerous for RVs, parking and bikes to go through
- Find solution as community
- Have compassion not clean up, wipe out or move
- Offered jobs to the homeless

#### Gale Brownell commented as follows:

- Involvement with homeless and affordable housing
- Clear succinct staff report
- Experienced pubic safety and other staff compassionate and do best they can
- Ask to join hands and sing kumbaya
- Incredible housing problem
- No place for them to go
- Things can happen
- Sympathetic to residents and businesses
- Do not deny there are problems

- Ask the City to tag along expansion of October 18<sup>th</sup> item
- Invited people who are involved in the homeless count for 2018

- Do in compassionate and tough love way

ila Benavidez-Heaster commented as follows:

- Money to Sonoma County breaking news
- City on top of it

- Will need agenda item to take formal action

Mayor Slayter commented as follows:

- Discussed recommendations from staff
- Item #3 rescission of unenforceable ordinance

Councilmember Glass commented as follows:

- Makes sense
- Sets up expectation of enforcement when we cannot enforce

Councilmember Gurney questioned if this is the 72-hour rule. Chief Conner stated it is not; it is the no camping in vehicles ordinance.

Councilmember Gurney questioned if this affects the 72-hour ordinance. Chief Conner stated it does not.

Vice Mayor Hinton commented as follows:

- 5 camping vehicles a of hit scorning
- Noticed a lot less

- Why less
- Discussed outreach

#### Chief Conner commented as follows:

- Not sure why there is less
- Discussed the history
- Discussed the vehicles currently there now
- One is parked there because of no where to store the vehicle
- Of the 5 did not recognize them

Councilmember Carnacchi commented he would like to see whole ordinance before rescinding it.

#### City Manager McLaughlin commented as follows:

- Not asking for action tonight
- All have to come back to council on subsequent agenda

The Council was in consensus to return the rescission of the ordinance as an agenda item.

- Discussed enacting this in order for people to stop parking their vehicles there
- Clear in the public record
- Have legal problem if enacted
- Not go into world of unintended consequences
- Discussed personal experience when working at Board of Supervisors and dealing with a homeless person and his RV everything was crushed in jail for more than 90 days
- Situations happen to people who are homeless
- Discussed people who come out of those circumstances moving forward
- Some have mental, emotional, addiction issues
- Discussed dealing with behavior if destructive
- Issue is behavior, not where their home is
- Police Department does good job of community policing
- Not saying there are not problems
- How deal with those problems kick the can down the road or look at how to better address these problems first
- Come together as community form group talk of proactive things we can do
- Use funds to effectively help with this problem
- Different homeless population living in RVs and those living outside

- Help address the issues
- Have received letters from businesses on Morris Street who have not observed problematic behavior
- Form stake holders group
- Take further action after more thought

Councilmember Gurney discussed the group meeting on the homeless.

#### Councilmember Gurney commented as follows:

- Volunteered for Laguna Clean Up Day
- Chose assignment to walk along Morris Street
- 7 vehicles on Saturday morning
- All working on this
- Watchful and proactive
- Looking for evidence that people were living there and trashing the area
- Got one piece of evidence
- Pleased to have that experience
- Appeared if living there, self-monitoring and keeping the area neat
- Concern of unintended consequences if regulate this not taking care of the issue will move or creep elsewhere
- Discussed personal observances on her street
- Discussed more highly conflicted complaints
- Resolution that is effective for people
- Discussed parking hours hard time with that recommendation
- Those times are backwards
- Heard concern of safety issues; public health issues witnessed at times when people are there
- Prohibiting at middle of night did not make sense
- Not know of way right now to set hours
- Find out way of who would participate if convened big stakeholder group or committee

#### Mayor Slayter commented as follows:

- Stated this would need to come back to the Council.
- Existing conditions seem to be well managed
- Law enforcement being social services
- Not fair to police or person needing social services
- Discussed timed parking
- Received correspondence for both sides of the item

- Not seeing justification to take this type of action
- All for taking deeper look
- Empaneling sub-committee

#### Item #2

#### Mayor Slayter commented as follows:

- Sounds related to camping issues but it is not
- Protection of residential zones
- Private street not to provide parking for those oversized vehicles
- Parking for limited duration
- Not see looking at this would cause issue for homeless encampment living
- Not see as same issue

#### Councilmember Glass commented as follows:

- Talking of not storing oversized vehicles
- Addressing issue of parking/leaving any kind of large vehicle (boat, RV) for more than 72 hours

#### Chief Conner commented as follows:

- 72-hour parking is separate and distinct
- Discussed exceptions for parking large vehicles
- Not appropriate place to store or park that type of equipment
- Not related to hours
- In residential areas define what are residential areas
- City would need to define

#### Councilmember Gurney commented as follows:

- Discussed ban of inhabiting vehicles
- Discussed unhitched rule
- Discussed vehicle and hitched trailer can they stay there one night is that illegal or role down street in 72 hours in residential area
- How long can they stay

#### Chief Conner commented as follows:

- Discussed ban (working to rescind)
- Lawful to sleep in car
- Can stay for 72 hours

#### City Manager McLaughlin commented as follows:

- 72-hours in vehicle code
- Some cities have expanded that law
- Discussed combinations of exemptions applicable to cities
- Provided examples of exceptions
- Are extreme cases where streets that are not properly designed created dangerous line of site situations
- Having to do with recreational vehicles in neighborhoods where neighbors are not designed to accommodate these vehicles

Vice Mayor Hinton commented as follows:

- Discussed unintended consequences
- Stated this is about Morris Street
- May become issue if put rule on Morris Street
- May be pushed to neighborhoods
- Why establish anew rule to deal with something we have not heard about

Chief Conner stated he has received complaints of oversized vehicles and line of site issues.

Councilmember Carnacchi questioned if this is in the zoning code update.

City Manager Mclaughlin commented as follows:

- Not addressed in the zoning code update

Councilmember Gurney commented as follows:

- Have heard complaints
- Not uncommon in old parts of town
- Had complaint on Pleasant Hill Road complaint of light from RV that was parked in one spot for days
- Benefit the City to take a look at this

Councilmember Glass commented as follows:

- Received complaints
- Look at other City ordinances
- See what is pertinent to this City
- Return to Council

Councilmember Carnacchi commented as follows:

- Discussed the CofC meeting
- Submit letter of situation and what working towards
- In interim use self-cleaning toilet that they could pay for
- One immediate ask
- Be heard and secure money
- Prepare letter to the CofC

The Council referred this item to staff and to have this item return to the City Council as discussed above. City Council Action: Directed staff as follows:

Engineering Manager Mikus presented the report to the City Council recommending the City Council approve the Resolution for submittal of a Jurisdictional Basin Boundary Adjustment Request to the California Department of Water Resources so that the entirety of the City is part of the Santa Rosa Groundwater Sub-Basin and accept the informational report.

Mayor Slayter opened for questions.

Mayor Slayter commented as follows:

- Discussed conference call with DWR
- Recommendations coming from State Staff stated it is DWR recommendations about whether or not our boundary adjustment should be approved
- Last bullet item Any risk of Santa Rosa Plain being reclassified as high due to the additional load
   Staff stated he does not think so –tiny compared to rest of basin order of magnitude –
   discussed thresholds needing to be hit Santa Rosa is already high priority (Per Mr. Rosenblum)
- Discussed Item 6 answer is no so what is the point
- Wilson Grove was under working knowledge it was very low not low ?— This was raised in May (per Mr. Rosenblum)
- Staff report/resolution incorrect Staff stated it should say very low will correct resolution

Councilmember Carnacchi commented that if we are drawing water from Wilson Grove basin, how would we affect Santa Rosa – not possible is it.

Staff stated they are inter-related – more so along our boundary - Wilson Grove recharges the Santa Rosa Plain.

Mayor Slayter opened for public comment.

Colleen Fernald commented as follows:

- Discussed water sheds to be protected by this City Council
- Can have flexibility with boundaries
- Not know how two ground water basins are inter-related
- Who make assessment happen
- Conflict of interests
- No accountability
- Do not choose
- Tell State need to have oversight
- Discussed damage to water if leave control of water shed
- Need to be player with Water Agency and have stake and legal ground

Bill Mattinson commented as follows:

- If clear in Santa Rosa Plain Sebastopol will have a vote
- GSA has responsibility under laws to protect their ground water
- Water Agency told if someone outside Santa Rosa GSA even in Wilson Grove can put in test wells and take action would be protected
- Have vote and voice

#### Mr. Rosenblum commented as follows:

- Wilson Grove extends under Santa Rosa Plain
- Discussed sponge affect
- Will eventually affect all wells
- Water engineer
- Not a geologist
- Have volunteered to help with technical issues
- County and Water Agency interest to provide support letters
- Approach to get support letters
- Do not meet until after the deadline
- Important to get letters now
- Nothing guaranteed that Sebastopol can join
- Objective is to get the Wilson Grove area back down low or very low
- About collaboration
- Big players who are not transparent
- Important to have assertive representation

Councilmember Glass moved and Vice Mayor Hinton seconded the motion to approve the Resolution supporting Sebastopol applying to the California Department of Water Resources for a Jurisdictional Boundary Adjustment to include Sebastopol in the Santa Rosa Plain Sub-Basin for the purpose of most effectively complying with the Sustainable Groundwater Management Act of 2014 as discussed and approved at the September 4, 2018 Council meeting with the correction low risk to state very low risk.

#### Discussion:

Councilmember Carnacchi commented as follows:

- Challenge risk originally vote against it
- If join Santa Rosa GSA, that all of our liablity and responsibility to the Wilson Grove basin is cut
- All strings are cut
- Problem with that
- Cannot they use it from the other side going the other way
- Concern of cutting the string from the source that we draw water from
- Should challenge science

Councilmember Glass commented it is estimated the cost to create own GSA is over a million dollars.

Staff stated it is double that figure.

Councilmember Glass commented as follows:

• \$2.3 million versus \$100,000

City does not have millions of dollars

#### Councilmember Carnacchi commented as follows:

- Talking of our water supply
- Sustenance of life
- Should not be a cost

#### Manager Mikus commented as follows:

- Discussed fighting this with DWR
- Erroneous to think that just because we are joining Santa Rosa that that avenue has been abandoned
- At latest TAC meeting Received letter from Jay Jasperse
- Water Agency and GSA continuing to push the issue
- Letter hit all technical issues
- No one giving up on it
- Will share letter

#### Councilmember Gurney commented as follows:

- Looking at points
- Mentioned if something came up in future would be able to address a bad actor or if circumstance change can address that
- Answer to Councilmember Carnacchi's concern

#### Councilmember Glass commented as follows:

- Standing to address issues that were technically incorrect
- GSA- have access to legal advice and technical expertise

#### Councilmember Carnacchi commented as follows:

- Asked for DWR to attend meeting
- Getting maybe answers
- Not really sure we will have this kind of leverage
